PETITION FOR DISSOLUTION OF MARRIAGE

Petitioner, ANNIE JACOB ("ANNIE"), individually and by her attorneys, BERGER
SCHATZ, pursuant to 750 ILCS 5/101 *et. al*, petitions this Court for dissolution of her marriage
to the Respondent, LEON JACOB ("LEON"), and in support thereof alleges the following:

1. ANNIE resides at [REDACTED], Northbrook, Illinois, and will have maintained that residence for at least ninety days immediately preceding the entry of a Judgment for Dissolution of Marriage.
2. LEON resides in Houston, Texas.
3. The parties were married on December 29, 2001 in Wilmette, Illinois and the marriage was registered in Cook County.
4. ANNIE is presently 34 years of age and is employed as Senior Corporate Attorney with Astellas U.S. LLC.
5. LEON is presently 36 years of age, is a physician but is currently unemployed.

6. Two children were born to the parties during their marriage, namely [REDACTED] [REDACTED] (currently 4 years old); and [REDACTED] (currently 15 months old). No other children were born to or adopted by the parties and ANNIE is not presently pregnant.

7. On August 26, 2013, the court in Allegheny County, Pennsylvania entered a Consent Agreement and Order to Vacate PFA Order which granted ANNIE temporary physical and legal custody of the parties' minor children and permitted ANNIE and the minor children to relocate from Pennsylvania to Illinois in exchange for her vacating the protection from abuse order that was previously entered against LEON. Further, the Consent Agreement provides for a supervised visits between LEON and the minor children in Illinois.

8. It is in the children's best interests that ANNIE be awarded sole custody of the minor children with LEON continuing to have supervised visitation.

9. To ANNIE's knowledge, there is no other Petition for Dissolution of Marriage pending in any other county or state.

10. Irreconcilable differences have caused the irretrievable breakdown of the marriage. Efforts at reconciliation have failed, and future attempts at reconciliation will be neither practical nor in the best interest of the family.

11. In the alternative, LEON is guilty of extreme and repeated mental cruelty without cause or provocation by ANNIE.

12. During the marriage ANNIE and LEON have acquired certain marital property, and each party should be awarded an equitable proportion of that property.

13. LEON is well able to support himself and to contribute to the support of the minor children. Therefore, LEON should be barred from any maintenance, including temporary or permanent, and should be required to contribute to the support of the minor children.

14. Each party has or will have sufficient income and financial resources to pay for his or her own attorneys' fees, experts' fees and costs incurred in connection with this litigation, including marital property to be assigned to him or her pursuant to any Judgment of Dissolution of Marriage entered in the above-captioned cause.

WHEREFORE, Petitioner, ANNIE JACOB, respectfully requests that this Court:

- A. Enter a Judgment of Dissolution of Marriage in favor of both parties;
- B. Award ANNIE the sole care, custody, control and education of the minor children with LEON having supervised visitation;
- C. Require LEON to pay child support for the minor children, and contribute to their health insurance, education expenses, extracurricular activity expenses, child care expenses, and uninsured medical expenses;
- D. That each party be barred from receiving maintenance;
- E. Award each party an equitable portion of the marital property;
- F. Require each party to pay his/her own attorney's fees and costs incurred in this action;
- G. Grant such other relief as this Court deems just and equitable.
